Community Survey Results

In March 2006, 400 adult residents of Yellowstone County were interviewed by telephone to determine opinions about life in the county and perceptions about ExxonMobil. What did we learn?

Overall, views of life in Yellowstone County are positive. A large majority of residents believe the county is a healthy and desirable place to live. However, life can be improved, respondents say, by more jobs, better roads, and expanded job skills training.

Specific to ExxonMobil, the public holds the company in high regard as a safe, trustworthy neighbor. However, two survey responses concern us. Less than half of respondents feel that we keep the public informed and respond to community concerns. Only four in ten say they know what to do in the event of a hazardous chemical release. In 2007, we will work to address these issues through the Community Advisory Panel and other initiatives.

Community surveys are one way we gauge public opinion at ExxonMobil Billings. Your phone calls, letters, and in-person queries are always welcome.

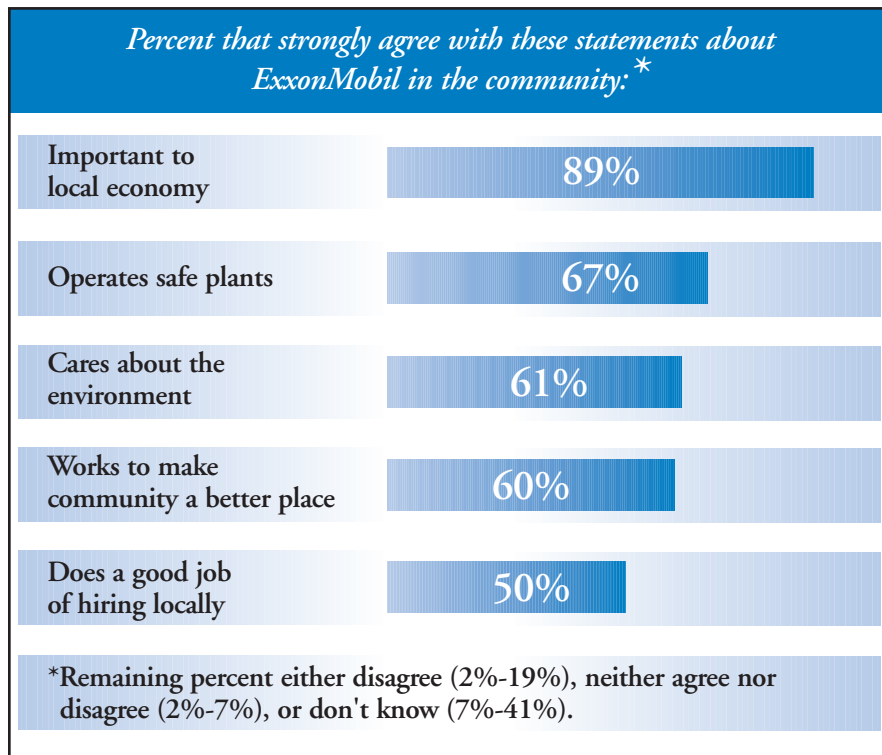
Additional survey results:

Safety and environment – Most people believe that ExxonMobil works well with emergency responders (59%), cares about the environment (61%), and complies with environmental regulations (58%).

Community contributions and economics – Six in ten feel that ExxonMobil supports the community through contributions (62%) and employee involvement (61%). Almost nine in ten feel the refinery is important to the local economy.

Awareness and image – Forty-three percent think first of gas, oil, and fuel when they hear the word ExxonMobil. Less favorable first thoughts include high gas prices, oil spills, big business, and pollution.

Quality of life – Sixty percent say that ExxonMobil has made the quality of life in Billings better.

Safety Sound-Off

For on-site safety of employees and visitors, the refinery tests its emergency warning system every Wednesday at noon. A single loud blast of a steam whistle warns of a fire or process plant evacuation. A high-pitch, multi-tone siren warns of a vapor release.



Employees are regularly trained for appropriate response in the event of a real on-site emergency. Before entering the refinery, all visitors are oriented with a site safety video.
